THIS LIST CONTAINS THE INFORMATION CONCERNING PARTICIPATIONS, LEGAL PERSONS AND COMPANIES AS REFERRED TO IN ARTICLES 379 AND 414 OF BOOK 2 OF THE DUTCH CIVIL CODE. THIS LIST FORMS PART OF "OTHER INFORMATION REGARDING KONINKLIJKE PHILIPS N.V." OF THE 2020 ANNUAL REPORT.

This list distinguishes between eight categories of subsidiaries and other affiliated companies:

- [1] a subsidiary, being a legal person in which Koninklijke Philips N.V. or one or more of its subsidiaries, pursuant to an agreement with other persons entitled to vote or otherwise, can exercise solely or jointly more than one-half of the voting rights at a general meeting of shareholders, and which is also a group company and is therefore **consolidated**;
- [2] a subsidiary, being a legal person of which Koninklijke Philips N.V. or one or more of its subsidiaries, is a member or shareholder and, pursuant to an agreement with other persons entitled to vote or otherwise, can appoint or dismiss, solely or jointly, more than one-half of the officers or of the supervisory board members, if all persons entitled to vote were to vote, and which is also a group company and is therefore **consolidated**;
- [3] a subsidiary, which is a company acting in its own name for the liabilities of which Koninklijke Philips N.V. or one or more subsidiaries is, as a partner, fully liable to creditors and which is also a group company and is therefore **consolidated**;
- [4] a subsidiary as referred to under [1], [2] or [3] and which is also a group company, however which is **not consolidated** as it is of negligible importance from the point of view of the requirement to provide a true and fair view of the total activities;
- [5] a subsidiary as referred to under [1], [2] or [3] and which is also a group company, however which is **not consolidated** as its necessary data can only be obtained at disproportionate expense or with a long delay;
- [6] a subsidiary as referred to under [1], [2] or [3] which is not a group company and is therefore **not consolidated**;
- [7] a group company which is not a subsidiary as referred to under [1], [2] or [3] and, however which is **consolidated**;
- [8] Other **not consolidated** affiliated companies in which Koninklijke Philips N.V. directly or indirectly holds an interest of 20% or more.

If no category is mentioned in the list below, the subsidiary belongs to category 1 or 2.

If no participation percentage is stated, the participation percentage is 100.

Participations indicated with α are shareholdings of Philips India Limited.

Participations indicated with « are shareholdings of Philips & Lite-On Digital Solutions Corporation.

For a number of companies established in The Netherlands belonging to categories 1 and 2, Koninklijke Philips N.V. has declared in writing, pursuant to article 403 of Book 2 of the Dutch Civil Code, to be jointly and severally liable for debts arising from legal acts of this company. These companies do not comply with all the requirements of Chapter 9 of Book 2 of the Dutch Civil Code. If Koninklijke Philips N.V. is not jointly and severally liable for a Netherlands-based company belonging to the categories 1 and 2, this participation is indicated with #.
